**EMERGENCY POWERS (COVID 19 PANDEMIC)
(MANAGEMENT AND RECOVERY)(NORTH ANDROS,
CENTRAL ANDROS AND CAT ISLAND LOCKDOWN)
(AMENDMENT)(NO. 3) ORDER, 2021**

In exercise of the powers conferred by the Emergency Powers (Covid 19 Pandemic)(Management and Recovery) Regulations, 2021, I HEREBY make the following Order —

1. Citation.

This Order may be cited as the Emergency Powers (Covid 19 Pandemic) (Management and Recovery)(North Andros, Central Andros and Cat Island Lockdown)(Amendment)(No. 3) Order, 2021.

2. Amendment of order 1 of the principal Order.

Paragraph (2) of order 1 of the principal Order is amended by the deletion of the word “8th” and the substitution of the word “ 14th”.

3. Amendment of order 4 of the principal Order.

Order 4 of the principal Order is amended by the deletion of the word “fourteen” and the substitution of the word “twenty-one”.

4. Amendment of order 6 of the principal Order.

Pararagraph (2)(d) of order 6 of the principal Order is amended by the insertion, immediately after the word “watering” of the words “, tending to and harvesting”.

5. Amendment of order 7 of the principal Order.

Paragraph (3) of Order 7 is amended—

- (a) in subparagraph (d), by the deletion of the fullstop and the substitution of the words “; and”; and
- (b) by the insertion immediately after subparagraph (d) of the following new subparagraph—
 - “(e) the harvesting of crabs shall be permitted—
 - (i) between the hours of 8:00 pm and 5:00 am; or
 - (ii) outside the hours referred to in subparagraph (e)(i), on the approval of the Royal Bahamas Police Officer in Charge for North Andros or Central Andros.”.

6. Amendment of order 9 of the principal Order.

Paragraph (2)(d) of order 9 of the principal Order is amended by the insertion, immediately after the word “watering” of the words “, tending to and harvesting”.
